- General registration opens *February 15th* and will be processed on a first-come, first-served basis.
- Registration is not complete until Camp Registrar has received via U.S. mail all required camper registration forms found at <https://www.mountainvalleyqscamp.com/registration.html>.
- Cancellations received by *June 30th* will be refunded in full, (minus \$25 non-refundable deposit and \$25 non-refundable GSUSA membership fee). After *June 30th*, registration fees are **not** refundable. Exceptions may be made at the discretion of the camp director, if space can be filled from waitlist.
- Unpaid registrations (as of *June 1st*) are subject to cancellation.
- Sweatshirt, Picture, and BBQ order information can be found on the "forms cover sheet".
- Transportation: Parents/guardians are responsible for transportation/carpooling to and from camp.
- In case of emergency, illness, severe homesickness, or discipline problem, parents will be notified by a phone call and will be expected to come to camp early to pick up their daughter.

### **ABOUT US: Mountain Valley Community Camp**

- Mountain Valley Community Camp (MVCC) is a one-week Girl Scout resident (overnight) camp.
- This camp is held at Camp Lyle McLeod which is owned and operated by Girl Scouts of Western Washington and is located on the Kitsap Peninsula just outside Belfair, Washington.
- Camp Lyle McLeod has a lodge, swim dock, boat dock, archery range, art loft and numerous camping units surrounding the tree-lined shores of beautiful Lake Bennettsen.
- MVCC is staffed by adult, community volunteers, all of whom receive pre-camp training.
- All meals (except one dinner and two breakfasts) are cooked and served in the lodge by certified cooks that have developed an absolutely delicious and nutritious menu.
- Program areas staffed by certified volunteers include boating, swimming and archery. Additional program areas include arts & crafts, music, games, campfires, star and meteor showers, s'mores and so much more.
- Adult unit counselors oversee each unit that is comprised of a cook shelter, a fire circle and sleeping cabins.
- For the care and safety of everyone at camp, the Health House is staffed by a certified healthcare professional.
